IPOA

On its twitter profile, IPOA, the Independent Policing Oversight Authority, identifies itself as a “state authority created under an Act of Parliament No. 35 of 2011”. Perhaps, there are those who have been aware of the existence of this body since its creation, but it only recently appeared on my radar, thanks to *Twitter*. The posters requesting nominations for the Outstanding Police Service Awards made me consider that it might actually be ‘active’. They have run full page advertisements in the local papers, as well as sending out tweets. Whoever engaged a PR company for the security services, picked a good one [this is not a fact, just speculation].

I am not the only one who has been oblivious to the existence of the IPOA, in exchanges with complainants on *Twitter*, the NPS account often has to point out that these organs do exist:

The IPOA does appear to have awakened to its obscurity fairly recently, as it is currently undertaking sensitisation trainings of police personnel who should have long been aware of the IPOA and its role.

Perhaps, the correct framing is that it has been ‘revived’ or maybe even ‘activated’, maybe by IG Boinnett. Makarao, whose name is slang for police, indicated support:

@IPOA_KE Good job you guys are doing. We are behind you (Makarao, 2015)

By presenting itself not only as a means for checking errant police but also as the source of rewards for outstanding performance, they manage to project objectivity to both civilians and police. This month’s report reflects on the value of being seen as objective and neutral when it comes to obtaining the public trust. I posit that though most people in Kenya would agree that everyone has an agenda, they have a tendency to trust those that strive to appear as if they do not. Once the performance of neutrality is no longer in effect, they are relegated not from a

position of credibility, even though doing so may have the effect of accruing power by gaining partisans. The IPOA has been able to position itself as an impartial institution, which I often purport should be the goal of the actors in the security services if they seek to be trusted.

Mandera's Mass Graves

Extra judicial killings, disappearances and harassment as a facet of anti-terror measures is quite a contested topic. The hashtags #DisappearancesKE and #SomalisStandUp offer insights into the conversations that are being had. Including, the security apparatus's co-option of #disappearancesKE to send anti-radicalisation messages. Running counter to the allegations are the arguments that a) in the case of the killings and disappearances, they do are not conducted by government security agents, perhaps they are the work of terrorists and b) that some level of harassment is necessary in the current security climate. There seem to be three factions: Ethnic Somali Muslims and other Muslims and their allies, government security institutions and their allies and a public that would view extra judicial deaths as wrong but is not convinced that they are actually occurring (which includes a contested definition of 'extrajudicial', what is a combatant, etc.?). Another facet of this sentiment is that

some 'other' Kenyans' attitude that Kenyan Somalis could be doing more in the fight against Al Shabaab, by 'giving up' radicalised individuals.

#SomalisStandUp and join hands, no one will fight for your rights let's say no to extrajudicial killings, we are also Kenyans not terrorists (HassanHag, 2015)

When innocent students were killed in Garissa you went silent. Sasa #SomalisStandUp ni ya nini ?? #SomalisShutUp (RoadsAlertKE, 2015)

@RoadAlertsKE Do innocent Somalis have to pay for what Al Shabab did?? (MahmudSaid7, 2015)

It's time #somalisstandup & give information on who this Alshabaab members are! just like the kikuyu did with their own mungiki! (RoadsAlertKE, 2015)

In Kenya when you disappear there're two things involved either you've joined alshabaab or you wanted to join alshabaab #DisappearancesKE (Tituskimanthi, 2015)

GOK shoots itself in the foot by ignoring and alienating Kenyan Somalis who should be its main ally in the #waronterror #SomalisStandUp (Aliasjg, 2015)

All of this is enmeshed with partisan politics, when it boils down to it, there is very little in Kenya that can escape that vortex. There are few voices that are seen as objective when it comes to this topic. How Mohamed Ali of *Jicho Pevu* deals with the Mandera mass graves incident exemplifies a process of shedding the veneer of objectivity and how that goes hand in hand with a loss of credibility.

On December 6, local NEP (North Eastern Provinces) leaders post pictures of a burial site near Mandera, describing it as a mass grave. The NEP is home to majority ethnic Somalis and has long been aggrieved and marginalised—initially on purpose due to an attempt to secede at independence and later due to negligence. The expectation amongst locals appeared to be that digging would yield the bodies of people that local families had declared missing. (See: #DisappearancesKE). Whether this expectation was held by a majority of the locals or only a few, is lost in the hub-bub:

The search for missing mother of five in Mandera leads to shocking discovery of mass graves of dozens of victims of enforced disappearances (Bkerrow, 2015)

Billow Kerrow is a Senator for Mandera, living in Nairobi. A journalist for KTN, Mohammed Ali also known as 'Moha' was also sharing this information with his shocked followers. No

one wants to believe it, but Moha, the presenter of *Jicho Pevu*, a popular investigative programme which unearths corruption and other underhanded dealings, is a credible source. Moha – *JichoPevu*, as he is affectionately known, has produced stand-alone programs for *Al Jazeera English* including *Killing Kenya*, which looks into claims about extra judicial killings in the country. Of Somali heritage and raised at the coast; Moha is well respected and considered ‘fair’. Given his work on *Killing Fields*, the reports about Mandera must have represented for him direct evidence for what he believed to be true:

Mandera mass Graves. This madness should come to an end. One of the victim is a woman. #Killingkenya (Mohajichopevu, 2015)

More Mass Graves discovered in Mandera. #Killingkenya (Mohajichopevu, 2015)

The horrified responses included some from public figures such as former Minister of Justice and presidential aspirant, Martha Karua, who seemed assured of the reliability of the sources. KTN news that night included a feature on the Mandera Mass graves including a press conference by NEP leaders in Nairobi:

Kudos to @MohaJichoPevu & others for exposing the #Manderamassgraves the mainstream media is on it now we need answers @ODPP_KE @UKenyatta (MarthaKarua, 2015)

Security representatives i.e. CS Nkaiserry, was fit to be tied, he indignantly denied that there were any mass graves and even secured court orders for legal exhumation in readiness for the NEP leaders who were set to arrive from Nairobi the following day. CS Nkaiserry did however confirm that the body of a woman had been found and that she was known to them. He claimed that Isnina Mohammed, 48, was an Al Shabaab sympathiser known to cook for them when they were in the area. Some took his words to mean that he felt that she had deserved whatever had befallen her, although he did fall short of accepting culpability for her demise. The hashtag #ManderaTruth emerged and was used by the security apparatus and public alike.

Nkaiserry now claims the late mama Isnina was an Alshabab cook. So what? Do you just kill her? Why do we have a constitution? #ManderaTruth (Abass_KE, 2015)

Nkaisseri's callous comments about the murder made me shiver. So the poor woman was killed for being alshabaab's cook? #StopKillingSomalis (OkatsoJackline, 2015)

The readiness of Nkaiserry to obtain the necessary paperwork to facilitate the exhumation should have alerted those alleging the presence of mass graves to proceed with less certainty. Still, the following day, Mohamed Ali of *Jicho Pevu* made his way to Mandera with leaders from the NEP like Bill Kerrow and other interested parties:

We landed in Mandera this morning with a team comprising Kenya National Commission on Human Rights, Amnesty International, Independent Medical-Legal Unit (Imlu), Human Rights Watch & other organizations, and a pathologist, to exhume bodies from the graves discovered in Mandera for postmortem. Mandera MPs Mohamed Mohamud, Abdiaziz Ali Farah, Fathiya Mahbub & Shaban Ali Issak are also on board. A media team including Mohamed Ali & John Alan Namu of Jicho Pevu were also on board. We exhumed the body of the woman once again after county security team obtained court orders for the same. The pathologist examined the body; report is not out yet. We then proceeded to the site where the body was discovered to open more suspected graves. After it proved challenging with the tools, it was mutually agreed between the security team & ourselves to defer the exhumations using an excavator, to tomorrow morning insha Allah. I want to thank the county security team for their kind cooperation throughout this exercise today. Many thanks also to the organizations for their swift mobilization in this crucial matter of extra judicial killings (Kerrow, 2015)

The following day the party reconvened in order to conduct another search:

This afternoon we concluded our search for more bodies at Ledi in Mandera after excavations using a bulldozer failed to yield results. 2 days ago, local leaders in Mandera called me & other MPs from the county to advise us that the body of the late Isnina was discovered in a grave there. They also stated that there were several other graves, possibly holding more bodies in each. The following day, they confirmed again after a visit to the site; on both occasions accompanied by police. As leaders from the area, & aware of the several alleged cases of forced disappearances, we issued a statement to condemn the same and travelled to Mandera to seek due process of exhumations accompanied by anxious relatives of missing persons and local leaders. We made the statement in good faith, believing as everyone in Mandera did that the site held more bodies. Indeed, even the county commissioner was quoted in the media yesterday suggesting two possible graves. As representatives of the people, we take their concerns & aspirations seriously and did all we can to ascertain the truth in this regard. The one body of the deceased Isnina found in that grave is one too many as every life is sacred. Regrettably, the allegation of mass graves was not proven & as responsible leaders, we felt obliged to apologise to Kenyans this afternoon through a press statement we had issued together with the county security team. Our position regarding the alleged existence of extra-judicial killings & enforced disappearances however stands and we reiterated the same strongly in our statement. (Bkerrow, 2015)

Nkaiserry was vindicated, but still angry. Now that Senator Billow Kerrow had told the story as it had happened; it seemed supremely irresponsible that such a story could run without

proper verification. I watched the news report over and noted that one of the ‘eyewitnesses’ indicates that only body had been found and does not allege that there were any others. Some remain convinced of a cover up.

From the perspective of the security services, this probably feeds into their view that the media can unwittingly be used as an organ for spreading terrorist propaganda and that there is a case to be made for curtailing its freedoms.

#SecurityKe Ambassador Kimani: We cannot use democracy, freedom of speech, to demoralize our security agencies #SundayLive" (Safariwithselle, 2015)

@safariwithselle @InteriorKE You cannot use the war on terror as a blanket to abuse citizen's rights either. Cuts both ways (AbuBakrTdot, 2015)

In Kenya’s highly politicised environment, it becomes strategic for parties seeking the public trust to project neutrality. This is difficult; when reporting on the plight of ethnic Somalis is framed as an anti-Jubilee government attack, then denying that such a thing has happened becomes a pro-government stance, even when that is not your intention. This aim, of being non-political, is evident in the police’s framing of their interaction with Billow Kerrow et al. after their return to Nairobi. The media reported it as an ‘arrest’, while the CID preferred ‘recorded a statement’ and denied any arrest:

The security services possibly aimed to project understanding that Billow Kerrow et al. had not deliberately ‘incited’ the public but wanted to investigate the incident. Billow Kerrow was very gracious with the security services in his social media communications, which led some to speculate that he had been threatened. My assessment was that he understood the problem of being ‘the boy who cried wolf’.

In contrast to Billow Kerrow, Mohamed Ali of *Jicho Pevu* opted for defiance and refused to apologise. The security services seem to view him at worst as an Al Shabaab apologist, at best, an unwitting Al Shabaab propagandist.

If it touches on their small gods we are told to keep quite coz we are journalists. Well Mohammed Ali is not going to do so. GOD above me (Mohajichopevu, 2015)

North Eastern, Mombasa and the rest of the Country don't forget what this government did to you 2017. The killings, corruption and everything (MohaJichopevu, 2015)

RAILA ODINGA MAGUFULI WA KENYA. Nasema bila woga wala shauku yeyote kwamba kenya yahitaji Magufuli wake.... [RAILA ODINGA IS THE MAGUFULI OF KENYA. I say this without any fear or doubt that Kenya needs its own Magufuli] <http://fb.me/3RYicq5LT> (MohaJichopevu, 2015)

In a *Facebook* post, MohaJichoPevu shares a message he once received, which provides a rationale for why he would point a finger accusingly at the *Jubilee* government:

Mr Mohammed Ali, you are a young boy, apparently you just married the other day and you now have a son less than one year old. i want to give you a last warning. life is so precious if you don't know. LEAVE JUBILEE REGIME ALONE. WACHANA NA SERIKALI [*leave the government alone*]. WACHA KUINGILIA SERIKALI. UTAUMIA KIJANA [*young man, you will get hurt*]. KAMA UNATAKA KUPATA SHIDA UTAIPATA TU [if you are looking for trouble, you will find it]. FANYA KAZI ZAKO KWA MAKINI SANA [*do your work carefully*]. SITA KWABIA TENA [*I will not tell you again*]. KAMA UNATAKA KUWA MWANASIASA JIUNGE

NA OPPOSITION NA UNJUE KUNA CONSEQUENCES *[If you want to become a politician join the opposition but know that there will be consequences]*. YOU ARE WARNED YOUNG BOY. NEVER AGAIN OPPOSE OR CRITICISE GOVERNMENT. YOU CAN GO TO POLICE IF YOU WISH. I CAN EVEN GIVE YOU MY NUMBER I AM VERY POWERFUL. 0721 416582. NINAITWA *[my name is]* ROBERT WACHIRA.

Hii ni barua ya mtoto wa nyoka anayetaka kuwa kama joka kubwa linaloua wakenya kwa sumu ya ufukara na dhulma. Wacha nianze kwa kusema kuwa kijana huyu kwa jina la Robert Wachira ni mpumbavu na mtafuta sifa. Mimi kama mpekuzi katika hii barua yake nimeamua kuchambua mambo matatu na kufanya maamuzi yangu ya busara kuwa huyu ni mshenzi anayeabudu miungu midogo ya Jubilee na anayetumiwa kijinga na watu wajinga walio na pesa za kijinga zisizo na adabu na walioibia wakenya. *[This is a message from a baby snake that wants to become the kind of big snake that is killing Kenyans with the poison of poverty and oppression. Let me begin by saying that this young man known as Robert Wachira is a praise-seeking fool. I, as the in his message have discussed three points in order to assess this individual is an idiot who worships the small gods of Jubilee and is stupidly being used by idiots who have stupid, obscene wealth that has been stolen from Kenyans.]*

Mohammed ‘Moha’ Ali’s crusade once pit him against oppression in general, and won him a certain following. Now, I would not be surprised if he runs for office in the upcoming election. This trajectory is evident from the responses from his audience, who are in search for a non-partisan voice:

@MarthaKarua @MohaJichoPevu @ODPP_KE @UKenyatta As a president in waiting, do you think it was wise to tweet without confirmation first..??
(Gerahgaste, 2015)

Only God knows what is happening in #NEP coz nobody is telling kenyans the truth even our trusted media #ManderaTruth (Osodo_ken, 2015)

#ManderaTruth It was one body, @MohaJichoPevu and Co. took photos of it from a million angles and made it look like there were many (Kim_kikwai, 2015)

How I am supposed to support these people who manipulatively used lies to tell us that there was Mass Graves in NE where there was none?? (Muhahami, 2015)

@mohajichopevu You may not agree with this government but you are a strong brand stick to facts and let the people decide (Owinog, 2015)

@MohaJichoPevu iko shida *[yes, there is trouble]* but try n not be a catalyst to the chaos. Your influence is too huge n u know it (Namekiragu, 2015)

There are those who see political machinations rather than terrorist machinations behind this story. KTN, it should be noted, is considered an ‘opposition’ news organ. It is co-owned by former KANU leaders, including former President Moi. Plenty of the commentary on *Twitter*

demonstrated cynicism over the fact that Raila Odinga travelled to Mandera to attend the funeral of Mama Isnina.

Raila Odinga is in Mandera County to condole with the families have lost and reported their relatives missing (Nationbreaking, 2015)

Sad when people use death to whip emotions against the govt, worse when one RAO rushes to 'scene' to gain political mileage. #ManderaTruth (Timo___kim, 2015)

Thus, Moha - *JichoPevu* sheds the objectivity and trust that the security services are trying to claim.

Kibaraka huyo anahofia uwezekano wangu wa mimi kuwaambia jamii ya waisilamu wasifanye kosa tena kwani ni chini ya Jubilee mabwana zao wamevamiwa, watoto wao wameuawa na wengine kupotezwa, wake zao wameachwa bila ya waume, wengi wao walifungwa katika uwanja wa kasarani kama mbwa na kuzuiwa haki zao, Eastleigh wanazidi kuteseka,

garissa mauji kila mara, Mandera kila siku ni vihoja, Wajir vijana wanazikwa hai na kuteswa katika kambi za jeshi, Lamu, Witu, Mombasa na Ukunda sera ni hiyo hiyo ya kijambazi inazidi kutekelezwa na kikosi cha kupambana na ugaidi cha ATPU. Dhulma kila siku, hawapewi vitambulisho wala pasi za usafiri, polisi wamewafanya wao kama kitega uchumi, wanatusiwa na kuitwa magaidi kila tendo la ugaidi linapotokea, hii ndio hofu walionayo. Msiniogope mie bali mwogoponi Mungu aliye juu anayeona haya maonevu yenu na mliomsahau na kuanza kuabudu pesa. Wanaogopa sauti yangu kwa vijana wa Kenya wanaouawa kila siku na baadhi ya mapolisi jambazi, wanahofia vijana watainuka kudai haki zao za kuishi, haki zao za ki-katiba, wanaua vijana kwa jina la Mungiki, wanaua vijana kwa jina la wezi lakini hawawauzi wezi wakubwa wanaopora kila siku, wanaoshindwa kutoa nafasi za kazi kwa vijana hawa. Hawachagui dini wala kabila wao sasa wanaangamiza kila aliye na maono kwa taifa hili. Naarifiwa wana hofu kubwa na ndio maana wanajaribu kila njia kunipaka tope. Wamejua mie si mwoga na sishikiki na mtu yeyote ila Mungu. Wamejaribu kutumia watu Fulani kazini mwangu lakini wameshindwa, wamejaribu kuingia kwenye Facebook yangu, twitter na instagram lakini Mungu amewafanya kushindwa. Hila za kunilinganisha mimi na ugaidi ziliwashinda, hila za kunipaka tope ziliwashinda, hila waliobakia nayo ni moja tu. Hila ya kuniangamiza kabla sijatoa kichwa changu, kusimama imara na kupinga dhulma zao. Hofu yao ni ushawishi wangu kwa wakenya kwa ujumla waliokandamizwa na serikali gaidi iliyoshindwa kuwalinda na badala ya kuwaua magaidi inaishia kuua wakenya wasio na hatia. Kerrow, B., (2015), This afternoon we concluded our search for more bodies at Ledi in Mandera after excavations using a bulldozer failed to yield results. 2 days ago, local leaders in Mandera called me & other MPs from the county to advise us that the body of the late Isnina was discovered in a grave there. They also stated that there were several other graves, possibly holding more bodies in each. The following day, they confirmed again after a visit to the site; on both occasions accompanied by police. As leaders from the area, & aware of the several alleged cases of forced disappearances, we issued a statement to condemn the same and travelled to Mandera to seek due process of exhumations accompanied by anxious relatives of missing persons and local leaders. We made the statement in good faith, believing as everyone in Mandera did that the site held more bodies. Indeed, even the county commissioner was quoted in the media yesterday suggesting two possible graves. As representatives of the people, we take their concerns & aspirations seriously and did all we can to ascertain the truth in this regard. The one body of the deceased Isnina found in that grave is one too many as every life is sacred. Regrettably, the allegation of mass graves was not proven & as responsible leaders, we felt obliged to apologise to Kenyans this afternoon through a press statement we had issued together with the county security team. We exhumed the body of the woman once again after county security team obtained court orders for the same. The pathologist examined the body; report is not out yet. We then proceeded to the sight where the body was discovered to open more suspected graves. After it proved challenging with the tools, it was mutually agreed between the security team & ourselves to defer the exhumations using an excavator, to tomorrow morning insha Allah. I want to thank the county security team for their kind cooperation throughout this exercise today.
