Introduction

Food banks – charitable projects providing free parcels of food for people in need to take away, prepare and eat - have existed in high-income countries for decades, but their spread in the UK is generally linked to the establishment and growth of The Trussell Trust's member-based food bank network. Since 2011, The Trussell Trust has been publishing data on the volume of food bank use across their network, made available from their standardised data collection system. These data have almost exclusively been the source of information on food bank use for the UK and, in the absence of national food insecurity monitoring before 2016, have typically been used as a barometer for food insecurity. The Trussell Trust's model for food banks is also wellestablished, involving establishing relationships with third-party local social and health service agencies who provide referrals; requiring that people in need of assistance have a referral for use; collecting data through the referral system; and guiding their member food banks to follow-up with referral agencies if they provide more than three referrals to a single client in a 6month period.²

There is, however, increasing recognition of a much larger landscape of food parcel distribution through independent food banks not affiliated with The Trussell Trust. Early works³ by researchers in England, Wales and Scotland found that in some places where no Trussell Trust food banks existed, there were well-established independent food banks operating. In other places, both Trussell Trust and independent food banks were operating. More recent work by Sabine Goodwin on behalf of the Independent Food Aid Network has mapped over 800 food parcel distribution projects or food banks (for ease, referred to as food banks going forward) operating outside of The Trussell Trust's food bank network.

Although it is evident that there are a large number of independent organisations and charities distributing food parcels, little is known about

when or why they were established, how they operate, and whom they serve. This lack of insight stands in contrast with research produced about, and from, The Trussell Trust, which includes numerous studies on the characteristics of people using their food banks and ways of operating⁴, and qualitative studies of the user experience.⁵

To begin to fill these gaps we undertook a survey to build understanding of independent food parcel distribution projects operating outside of The Trussell Trust in England. We surveyed 114 independent food banks over September 2018 to May 2019. This user guide describes the methodology used to collect the data and to aid its analysis.

Questionnaire development

The content of the questionnaire was intended to gather information on the operational characteristics of independent food banks and the constraints on the help they can offer.

A topic guide was developed by the research team, covering details about the food bank premises and organisational characteristics, how the food bank project was staffed or supported by volunteers and how it was funded, how the food bank fit within its local food aid landscape, how the food bank operated, who it served and for what reasons, and the reasons for particular operating features, what kinds of data collection procedures were in place, strains on their services, what help they provided, and the respondents' opinions on the future of food bank use and how it could be reduced.

Questions were mostly multiple choice, though in many cases, were designed to enable respondents to select multiple answers where more than one answer was possible. Where there was concern the pre-determined response options may not adequately capture respondents' answers, an option of "Other" was provided, allowing respondents to provide their own response. They are left in the data set as uncoded qualitative responses.

Some questions were also posed as open-ended questions, with interviewers entering responses verbatim to the best of their ability. Open-ended questions were used when the range of possible options wasn't able to be captured in predetermined responses and where questions were exploratory.

The questionnaire went through multiple reviews by the project team and by external reviewers. It was pilot tested by 4 independent food bank managers and their feedback was incorporated into subsequent versions.

A first version of the questionnaire went live in the field in September 2018 and was answered by 21 survey respondents. A review of answers revealed that additional options were needed in responses options for a small number of questions. The question response options that were modified from October 2018 forward are indicated in the annotated questionnaire in the Appendix.

Sampling

The sample frame for this study was provided by Sabine Goodwin, who, over summer 2017 to Spring 2018, identified 558 food banks operating in England.⁶ These were defined as venues or distribution points which were distributing emergency food parcels at least once a week. Some of these were part of an umbrella organisation, which operated multiple food banks. The 558 food banks belonged to a total of 454 organisations. Of these, 89% operated only one food bank, 6% operated two food banks, and 4% operated 3 or more, up to a maximum of 14 food banks. Of the 558 food banks, we selected a random target sample of 179, representing 141 organisations. This sample size accommodated a 60% non-response rate to provide a margin of error of +/-8.5%.

Fieldwork and response rate

Fieldwork started in September 2018 and was completed at the end of April 2019. Recruitment was carried out at the level of the individual food bank's organisation, where relevant, since often a single staff member oversaw multiple food banks and could respond on behalf of each site, though all data collected relates to individual sites. Food banks were invited to participate in the study by email or by telephone. Initial approaches were followed up by telephone calls and/or emails if a first approach yielded no response.

Upon inviting the 179 food banks to participate in the study, it was discovered 12 food banks from one organisation were no longer providing a weekly distribution service, rendering them ineligible to participate. A further seven food banks were no longer operating, and one other food bank was discovered to be a part of The Trussell Trust's food bank network. Of the remaining 159 eligible food banks, 114 participated, reflecting a response rate of 71.7%. Some of the food banks were part of a wider food bank organisation. Thus, a total of 79 food bank organisations were represented in the sample.

Reasons for non-participation included organisations or food banks being too busy (reason given by 5 organisations, covering 10 food banks), recent bereavement of potential respondent (n=2 food banks), or managers being unwilling to complete the survey by telephone (n=4 food banks). Six food banks indicated interest in participating, but did not reply to subsequent emails to arrange a time for the telephone survey. An additional seven organisations (n=8 food banks) declined without providing a reason and 15 food banks failed to respond to invitations to participate.

Data collection, coding and data checks

Data collected in the telephone survey were inputted directly into Open Data Kit survey software (https://getodk.org/) operating on tablet devices. This software enabled data to be backed up to a cloud as inputted (if connected to the internet) and outputted the responses into an excel sheet.

Data were checked and formatted using Stata. For yes/no questions, the following formatting was used:

The ODK data software outputted multi-item responses as string variables, where response options appeared in a list of combined options. These were extracted to be binary variables, indicating whether or not the response option was selected. These variables appear in the derived variable list.

One other derived variable is provided in the data set, relating to the year the organisation either started providing food parcels or the year the food bank started operating. See notes in annotated questionnaire and derived variable list.

Open-ended responses are string variables in the data set.

Where responses to open-ended questions could have led to a participating organisation being identified, responses were anonymised by removing place/city/town/village names by [place name].
