Section 1: Information and consent

The purpose of this survey is to include the experiences and opinions of people who have used drugs, plant-based medicines and other psychoactive compounds into the debate about the future of drug policy in the UK. We believe in giving a voice to a range of people that have personal experiences as they are often most affected by policy but often left out.

This is a confidential survey, your data is anonymous, we will not be able to tell who you are and we do not ask you for identifiable information. We do ask for your age, gender, ethnicity, religious beliefs and political beliefs. We are interested in whether your values surrounding drugs are affected by these factors.

The survey asks questions about your substance use history, where you get your substances from, if you have any experience of treatment or a criminal justice sanction. You will then be given a series of statements that will help us understand your values about substances, such as tobacco and alcohol, heroin, Magic Mushrooms, cocaine, cannabis, ecstasy.
